STATEMENT OF WORK (SOW)

1.0 INTRODUCTION

U.S. Probation – District of Colorado, a federal law enforcement agency under the Federal Judiciary, is seeking the replacement of 136 chairs for its judiciary employees and clients. Our office currently carries the Senator Ad-Lib stacking chair model. The Senator Ad-Lib and equal products shall be considered. Specific description and quantities are listed below.

2.0 SCOPE OF WORK

This scope of work is for the procurement, delivery, and installation of office furnishings which conform with the criteria set forth in this solicitation. Additional project goals include providing quality office furnishings that are durable, easily cleaned, functional, and incorporating design features which promote improved quality of work life.

2.1 REQUIREMENTS

Equal products to the Senator Ad-Lib chair shall be considered. The minimum characteristics that must be satisfied by any proposed equivalent must be met to be considered as technically acceptable:

<u>Item 1</u>

Quantity Required: 123

Guest chair, stackable, both 4 leg and sled base options, poly or plastic contoured seat, poly or plastic contoured back, fixed back, fixed arms, fixed seat, chrome or black frame, multiple color options that must include one of the following colors: dark blue, dark gray, or black, support a user weight of 300 lbs or more.

- <u>Item 2</u>
 - Quantity Required: 13

Guest chair, a 360 degree swivel base with a 5 leg "star" configuration, casters, poly or plastic contoured seat, poly or plastic contoured back, free floating tilt, fixed arms, chrome or black frame, multiple color options that must include one of the following colors: dark blue, dark gray, or black, support a user weight of 300 lbs or more.

Item 1 and Item 2 shall be new, of the same product line, and from the same manufacturer.

Contractors shall provide a comparison summary of the Senator Ad-Lib with the equivalent item(s) being proposed. The comparison summary should detail how the proposed alternate is equal to the Senator Ad-Lib chair as well as how it is not. Any difference between the specification of the Senator Ad-Lib and the proposed alternate should be clearly outlined.

Contractors are responsible to clearly and specifically indicate the product being offered and to provide descriptive literature, colored catalog sheets, pictures, and technical detail to enable U.S. Probation to determine if the product offered meets the requirements of the solicitation. Detailed material and construction specifications must be included. Failure to furnish adequate data for evaluation purposes may result in declaring a proposal non-responsive.

It is important that any manufacturers included in proposal have a proven history for providing quality furnishings, and that proposed product lines are available and not considered to be at end of life. Contractors shall provide only current production, new furniture. Used furniture or discontinued lines are unacceptable.

2.2 RANDOM SAMPLES

Random samples may be selected from proposed quotations, in order to assure conformance with this solicitation. The Contractor must provide a method for U.S. Probation to view an actual sample of item(s) offered, prior to award (e.g. via access to a showroom to view fully assembled representations of quoted furniture). Any sample materials and components are provided at no cost to U.S. Probation.

2.3 WARRANTY

Contractors shall include in their proposal a complete detailed copy of the manufacturer's warranty for the proposed items. The warranty policy should include length and how executed, method for determining manufacturing defects versus negligence, misuse or abuse, and explain how the manufacturer handles replacements of defective or damaged items.

2.4 COSTS PROPOSAL

Contractors shall provide a cost proposal for the Scope of Work using the Quote Sheet (Attachment A). Include all costs for:

- Furniture
- Shipping
- Delivery including all transportation, packaging, and crates
- Installation
- Clean-up

Shipping, delivery, Installation, and clean-up costs are a separate line item on Quote Sheet (Attachment A).

2.5 SCHEDULE FOR PERFORMANCE AND DELIVERY/MILESTONE SCHEDULES

Contractors to this solicitation must provide a schedule which shows:

- Estimated lead time
- Start of delivery
- Duration of installation
- Completion

The submission must include a preliminary project schedule based on the number of calendar days required to perform the work following the award of the contract. Include a chronology for completing the project, from the point the contract is issued until final installation. Include key milestones and identify the timing of all related pre-requisite activities.

3.0 DELIVERY AND INSTALLATION

- All transportation, delivery, installation, and disposal arrangements shall be the responsibility of the Contractor
- To ensure there is no conflict with the delivery of items the Contractor shall coordinate the delivery date and installation schedule of items with U.S. Probation. Contractor shall notify U.S. Probation no later than one week prior to delivery and installation of the furniture. Notification shall be made to Hoai Vu at hoai_vu@cod.uscourts.gov.
- Furniture delivery and installation must be carried out between 8:30 am and 4:00 pm on weekdays, or at other times by mutual agreement.
- Contractor shall have complete responsibility for items until they are unpacked, assembled, and installed in rooms at 1929 Stout St, Ste C120, Denver, CO 80294

- Contractor shall be responsible for the removal of crating and packing materials from U.S. Probation and the Byron Rogers Courthouse, including the removal of non-recycling and recycling waste materials which includes but is not limited to: pallets, plastics, rigid foams, padding, and cardboards
- Items shall be considered received when completely unpacked, assembled, installed in rooms and free
 of dirt, dust, marks, dents, scratches, tape, packaging or other foreign substances

3.2 REVIEW PERIOD FOR DELIVERABLE(S)

The U.S. Probation office shall be given 14 days to test, evaluate, and accept the items furnished under this contract. After 14 days the items are deemed accepted.

3.3 ACCEPTANCE CRITERIA FOR DELIVERABLE(S)

Unless otherwise specified in the solicitation or awarding documents, all deliveries shall be F.O.B. Destination. "Destination" shall mean delivered to the point specified in the purchase order. All items to be delivered pursuant to the contract shall be subject to final inspection and acceptance at destination. Title and risk of loss or damage to all items shall be the responsibility of the Contractor until accepted by the receiving agency. The Contractor shall be responsible for filing, processing, and collecting any and all damage claims accruing prior to acceptance. The Contractor shall prepay all packaging, handling, shipping and delivery charges and firm prices quoted in the offer shall include all such charges. All defective items must be replaced promptly at no additional cost.

4.0 EVALUATION FACTORS FOR AWARD

A single firm-fixed-price (FFP) contract will be awarded from this RFQ based on lowest priced, technically acceptable offer.






